The following discloses our information gathering and sharing practices for this specialty-branded web site and its related mobile marketing channel ("Web Site"). Please note that if we provide access other websites via links on this Web Site, those websites may have different privacy policies specific to those websites. We encourage you to read all third-party privacy policies because they will be different from this Web Site, and may pose different privacy and security risks.

1. Personal Information Collection

3. Our Use and Disclosure of Your Personal Information

services, and program participant surveys ("Internet Service Providers"). SHD Surveys may share your personal information with the Internet Service Providers as appropriate. We do not share personally identifiable information with outside third parties without your consent, except to the extent necessary to complete your request for products and services offered through the Web Site.

SHD Surveys may use your personal information to contact you via mail, e-mail, or electronic messaging in order to give you updates about SHD Surveys' special events, new products and services, current information regarding our products and services, or other promotions that may be of interest to you. We use return e-mail addresses to answer the e-mail we receive from you. SHD Surveys will not share your e-mail address with outside third parties for their direct marketing unless you give us permission to do so, but by registering with this Web Site, you authorize SHD Surveys to use your personal information for SHD Surveys' and affiliates' marketing purposes. We may use your IP address to help protect SHD Surveys and our Internet Service Providers from fraud.

Additional uses of your non-personal and personal information will allow us to tailor products and services specific to your needs. The information will help us organize and manage our relationship with you, conduct business, provide program participant support, perform functions that are described to you at the time of collection, and enforce this Web Site's Terms of Use.

We may use non-personal aggregate information to improve this Web Site. For example, our Internet Service Providers may report to us that there were a particular number of visitors to a certain area of this Web Site, or that a certain number of program participants completed our registration forms in particular areas of our Web Site. SHD Surveys may use such information to analyze the effectiveness of our marketing models.

4. Your Logon & Password

In order to maintain a secure environment, all program participants are required to use a login identification and password assigned to them by SHD Surveys to access the Web Site. The use of this logon identification and password provides program participants access to the information and data within the Web Site to which they, and they alone, have been specifically authorized access.

SHD Survey program participants are also responsible for the control and use of assigned login identifications and passwords assigned to them. They should not be shared with anyone.

Some general guidelines regarding passwords are as follows:

 As a best practice, your password should be changed every 30 days -- or whenever a compromise of the password is suspected.

- When you change your password, you should not reuse prior passwords for at least 6 months.

Notwithstanding our efforts, the Internet has inherent security risks. SHD Surveys cannot promise, and you should not expect, that your personal information, personal searches, and other communications would always remain secure. You should take care with regard to how you handle and disclose your personal information or any login or password that you are required to use to access services on this Web Site.

6. Children and Data Collection

SHD Surveys' Web Site is a general audience Web Site. SHD Surveys does not direct its Web site content toward children under 13 years old. We do not knowingly collect personal information from children.
